**Subject: Notice for indefinite hunger fast from 3<sup>rd</sup> Feb-2014 against the breach of trust and non-resolution of very basic issues in respect of direct recruited executives of BSNL.**

Respected Sir,

We, the direct recruited and professionally qualified executives, recruited after inception of BSNL in Oct-2000, have been continuously ignored and deprived of our very basic entitlements as recommended by DPE/DoT/GoI in respect of pay, career and superannuation benefits. On continuous persuasion of this association, various committees have been formed since last many years but all these committees have remained indecisive over the issues till date.

2. Management indifference and complete ignorance towards the issues raised at various platforms, forced this association to launch a countrywide protest in the month of Aug-2013. After a long protest of more than 20 days including mass Dharna for 12 days at Jantar-Mantar New Delhi, this association called off the protest when management agreed in writing to resolve the issues as per DPE/DoT/GoI guidelines in a time bound manner within a time frame of 2 to 3 months. The agreement was issued vide record of discussion attached herewith. But with deep regret, this is to state that even after passage of more than 5 months, none of the issues have been resolved by BSNL management till date. This is nothing but complete breach of trust and is definitely against the spirit to maintain the industrial harmony. Such ignorance and breach of trust has created a very high level of dissatisfaction and unrest amongst the directly recruited fraternity of BSNL which in turn is badly affecting the moral of the youngest work force in BSNL and ultimately the performance of the company. Hence we are forced to resume our agitational program.

Therefore, this is to notify that this association will resume its protest against the absolute breach of trust and non resolution of the issues despite the agreement by BSNL management (issued vide letter no. 31-4/SR/2013 dated 8<sup>th</sup> Aug-2013). The Program of Agitation is as follows:

1. **20<sup>th</sup> Jan-14 to 25<sup>th</sup> Jan-14:** Signature Campaign and Submitting the memorandum to various authorities in respect of our issues.
2. **3<sup>rd</sup> Feb-14 onwards:**
  - a. Indefinite hunger fast by office bearers of AIGETOA CHQ and some other volunteer members at BSNL CO New Delhi. (List will be submitted in due course of time).
  - b. Wearing badges of protest and observance of day long hunger fast indefinitely by members of this association. Members However shall continue to work and will not abstain themselves from duties during this time.
3. **10<sup>th</sup> Feb-14 onwards:** Mass indefinite hunger fast by members till resolution of the issues at Jantar Mantar New Delhi.
