Dear Sir,

W.r.t above referenced letter, we would like to inform you again that no action done by circle administration in the issues submitted to your end on 31-05-2014 except a tenure transfer order. A change in staff section is very much needed at this point as the referendum process for association verification is already initiated by Corporate office and some people have started association activities sitting in administrative chair which is very much harmful for the organization. So we request you to look into the pending issues seriously and take necessary arrangement for time bound settlement of the issues:-

(1) Release of Rule 8 pending cases:-

Despite repeated instructions from corporate office, for release of all R-8 Cases in phased manner who have completed 5 years of service, it is regretted that more than 70 R-8 cases are still pending in WBTC, these pendency is justified by administration citing shortage of staff.

Recently almost 80 JTO have been posted from promotion from TTA to JTO and direct TTA have also joined WBTC, but still none of these waitlisted R-8 cases have been implemented . We request the administration to clearly come up with action plan for release of all of these officers, since as an association we won't be able to bear the pressure from our members who are very upset after working for as long as 12 years in WBTC.

Further as agreed with the CGMT WBTC the spouse cases under R-8 which were approved and processed needs to be released, they are pending without any reason, causing unwanted mental agony to these officers. We also will like to remind you that further release of R-8 was promised by you after joining of DR TTAs.

(2) Look after SDE - Case of Mr. Shivkant Shukla for Kharagpur SSA:-

It has been noticed that in the last LA-SDE order issued during Jun 2014, case of Mr. Shivkant Shukla JTO Kharagpur ,has not been regularized though the case has been recommended by GM, Kharagpur and he is working as SDE(HR) since last year. We request for order in this regard , as he is also the DS of AIGETOA and this biasing will create undue confusion in the minds of members of our association.

(3) Transfer request in the cadre of SDET:-

Though it has been informed to you in last meeting and you directed DGM(Admin) to look into the delay but the case of Mr. Prahlad Basak, SDE(SW & BB), Malda who applied for transfer to Raiganj has not been issued till now.

(4) Posting of Direct Recruit in staff section:-

The previous case re-affirms our request for posting of neutral officers in staff section , which is being manned by officers from one particular association for a long time in WBTC. As it is clear from above that all our works are getting badly affected due to absence of DR in staff section. Even forwarding of letters to ALTTC/NCNGN have not been done though last date crossed. It clearly shows that negative forces are at their peak at this time, may be due to the upcoming elections. We request you to immediately post one DR-SDE and DR-JTO at staff section so that all types of work can be done neutrally and promptly and keeping in the association referendum going on we request the circle administration to have a very neutral and transparent approach towards all executives. The following officers are willing to serve in staff section:

(7) Intra-circle transfer request in the cadre of JTO:-

Mr. Jatin Das, JTO whose transfer order issued from Raiganj to Kolkata has not been released till date though 5 nos. of JTOs and 3 TTAs joined Raiganj during last 4 months.
